**Conditions of Booking**

Cheques should be made payable to OUTDOOR DIMENSIONS-SCOTLAND. The balance of the fee is due 28 days before the holiday or course commences and is non-refundable. It is a condition of booking that you understand and appreciate that there may be a small risk involved in these activities.

Outdoor Dimensions-Scotland strongly recommend that you take out suitable insurance with respect to personal accident and holiday cancellation insurance. Flexibility with routes is essential in case of inclement weather and clients must abide by the decision of the Leader or Instructor. Any losses or damage to equipment caused by the client must be paid in full before departure. If you have to cancel your holiday or course we must be notified in writing as soon as possible. If for any reason we have to cancel a holiday or course, an alternative holiday or course will be offered or a full refund given.
